In relation to the General Data Protection Regulation (Regulation (EU) 2016/679) and Organic Law 3/2018, of December 5, Protection of Personal Data and guarantee of digital rights, we will notify you on the use of your personal data and any other issues that may be of your interest.

What is the purpose of collecting and processing your data?

We collect your data to be able to invoice and make the collection of services contracted by you, which includes the use of your identifying and contact information or those of the entity you represent and, in case of payment by credit card, you will also be asked for your card information.

You have the right to withdraw your consent at any time.

How long is your data kept on file for?

We will store your data for a period of 5 years due to the existing tax regulations, after which we will destroy them if there is no conservation request from you.

What is the legal basis for the processing of your data?

The legal basis for the processing of your data is the billing and payment of the services contracted by you, and whose treatment is essential to carry out the collection of services.

To whom do I communicate your data?

In the collection of invoices, the banking entities that work with maximice events group SL will know your bank account information, in case you have provided it to us and pay by bank transfer.

In the case of payments by credit / debit card, the credit / banking entities that we use as a payment platform will know your card details, maximice events group SL directly collects your essential information to be able to make the payment.

What rights do you have on providing us with your data?

You should know that allowing us to process your personal data gives you the rights specified below:

- You may access all your personal data we process (right of access).

- You have the right to amend your data in the event it is inaccurate or has changed (right of amendment).
- Likewise, you may delete your personal data when our commercial relationship has ended. In some cases, you will not be able to delete all your data due to the existence of laws forcing us to keep your data on file for a period of five years (right of cancellation).
- You will have the right to ask us not to process your personal data (right of opposition).
- You will also be able to ask us to restrict the processing of your data in the following cases (right to restrict processing):
 - During the analysis of you challenge due to the inaccuracy of your data.
 - If the processing is illegal, you oppose the deletion of the data.
 - When we do not need to process your data, but you require it for the exercise or defence of potential complaints.
 - If you have opposed the processing of your data alleging public or legitimate interest, while we are analysing whether or not our reasons for processing prevail over your interests.
- Finally, you will have the right to us delivering your personal data in electronic format for the purposes of convenience (right of portability).

Data security

maximice events group SL collects, processes and stores your data in accordance with information security standards and policies. These security measures apply to information in both electronic and printed format, and guarantee the confidentiality, integrity and availability of your data. In the event of an occurrence or incident that compromises your data, we will notify you at the earliest possible opportunity.
